Includes a multi-lane roundabout with concrete paving at Taconic Dr and a new stormwater system to a basin.	\$7,000,000	Nov 2023	Jan 2024	Homan
Lake Hazel Rd and Eagle Rd	Widen and reconstruct the intersection with concrete pavement, replace the traffic signal, widen and reconstruct all legs of the intersection with asphalt pavement, add multi-use pathways throughout and a new stormwater system to a basin.
